

HOME INSTRUCTION ANNUAL ASSESSMENT NOTIFICATION FORM

Part 100.10 of the New York State Commissioner's Regulation requires all home schooled students to submit an annual assessment at the conclusion of the school year.

Grades 1-3 may submit either results from a commercially published norm-referenced achievement test or a written narrative.

Grades 4-8 must submit results from a commercially published norm-referenced achievement test at least every other year. A written narrative may be submitted on alternating years.

Grades 9-12 must submit results from a commercially published norm-referenced achievement test every year.

The test shall be selected and procured by the parent from one of the following: the Iowa Test of Basic Skills, the California Achievement Test, the Stanford Achievement Test, the Comprehensive Test of Basic Skills, the Metropolitan Achievement Test, a State Education Department test, or another test approved by the State Education Department.
